## I. INTRODUCTION AND FRAMEWORK

The purpose of this agreement is to help students meet their goals through block transfer articulation of credits earned in the Land and Water Management Diploma program at Assiniboine Community College (ACC) to the Bachelor of Applied Science: Environmental Management (BASEM) degree program at Lakeland College (LLC).

This agreement envisions enabling and assisting students who complete the ACC Land and Water Management program to articulate, with advanced credit standing comprised of full two-year block transfer into LLC's Bachelor of Applied Science: Environmental Management degree program. Specifically, students will be expected to meet the academic requirements and follow all academic policies of LLC, with the exception of specific items outlined in this agreement.

#### This agreement:

- 1. Is subject to the regulations and policies of Lakeland College and to the terms outlined below.
- 2. Transfers only into the LLC BASEM program through this agreement.
- Relies on the information as documented herein; as such the parties will communicate on significant changes to courses or programs listed in this agreement.
- 4. Relies on open communication between institutions. The contact for Lakeland College is the Dean, Environmental Sciences and the contact for Assiniboine Community College is the Dean, School of Agriculture and Environment.
- 5. All notices to be given pursuant to this agreement shall be in writing and emailed to the following individuals:

- 6. Will become effective immediately and is applicable to applicants who are graduates of ACC Land and Water Management program.
- 7. Has no specified end date, but either Party may terminate the agreement at any time, provided at least six (6) months written notice is given to the other Party. The agreement will be terminated on the date that the other Party receives the written notice. In the case of termination of the agreement, the Parties agree that any previously approved students shall continue and be completed as if the agreement had remained in force.
- 8. Will be reviewed after five (5) years by the Parties to ensure that the Agreement continues to meet the needs of each institution.

#### **II. GENERAL NOTES**

1. The Admissions Office at LLC has the final right of approval on admission decisions for all students.

2. To be eligible for block transfer credit, students must have completed the full course requirements and graduated from the ACC Land and Water Management diploma program with a cumulative GPA of 2.3. Individual credit for courses will not be granted through this agreement. Students who would like course by course assessment must go through the regular course transfer protocols. Courses which students were granted transfer credit into ACC programs may not be considered for transfer credit through this agreement.
