- i) Graduate Follow-Up Survey: A. Doerksen shared a presentation with the BOG that looked at survey results of the 2021-22 grads approx. nine months after graduation and 2018-19 grads four years after graduation.
 - Over all the results were favourable, a few areas were identified where the phrasing of the question will be reviewed.
- **ii) Fall Enrolment Update**: D. Adriaansen presented an overview of the new student fall enrolment as well as projections for the year and how that will impact the budget.
 - As of early September, the college is in good shape for the coming term with numbers rebounding from the COVID drop. International numbers are also looking healthy but the college remains cautions as student permit future is unknown at this time.
 - Parkland remains a soft spot in the college's enrolment, there are a number of meetings planned for the coming months to work on strengthening these numbers.
- iii) Policy B5 Complaints to the Board: This policy was review and discussed as part of regular policy review schedule.

Due to the value the Promissory Note requires the BOG Chairperson to sign.

That the Board of Governors approve the signing/ authorizing the \$510,000 promissory note issued by the Province of Manitoba for capital equipment related to the Practical Nursing expansion funding in Neepawa.
