Memorandum of Understanding (MOU)
Between
Assiniboine College
and
Providence University College & Theological Seminary

Purpose:

This Memorandum of Understanding (MOU) sets forth the terms and understanding between Assiniboine College (hereafter referred to as Assiniboine) and Providence University College & Theological Seminary (hereafter referred to as Providence) to collaborate on providing an academic pathway between the two institutions. This arrangement allows students at Providence to apply to Assiniboine's Practical Nursing program offered in Otterburne and receive competitive standing in admissions to the program at this this location.

Scope of this MOU:

The scope of MOU includes, but is not limited to:

1. Facilitating the application process for Providence Assiniboine's Practical Nursing program. No credit transfer to Assiniboine's Practical Nursing program is contemplated under this MOU arrangement.
2. Ensuring that students from Providence receive competitive standing as it relates to geographical reach within the existing admissions process to the Practical Nursing program.

Responsibilities of Each Party:

Assiniboine agrees to:

- Provide information about the Practical Nursing program and the application process including hosting program information sessions and providing one-on-one admissions support as needed to current students of Providence.
- Offer competitive standing in admissions to students from Providence as it relates to geographical reach (preference to these qualified applicants as living within 100km of the Otterburne Practical Nursing location).
- Collaborate with Providence to support students throughout the application process.
- Reserve the right to limit the number of students admitted under this agreement.
- Provide successful graduates of the college's program a Diploma in Practical Nursing.

Providence agrees to:

- Inform students about the arrangement and the opportunity to apply to Assiniboine's practical nursing program
- Work with Assiniboine to ensure a smooth transition for students entering the Practical Nursing program in Otterburne.
- Hold independent decision making and authority as to the credential granted by Providence to those who graduate from both Assiniboine's Practical Nursing diploma program and the additional courses required at Providence.

Duration:

This MOU shall remain in effect for a period of five years commencing July 1, 2025. At the end of this time, the agreement will be subject to review and renewal.

Terms and Conditions:

- Both parties agree to work collaboratively and in good faith to achieve the objectives outlined in this MOU.
- Any amendments to this MOU must be made in writing and signed by both parties.
- This MOU does not create any legally binding obligations but serves as a framework for collaboration.


