

## Application for IPM Continuing Education Credits

To request CEC approval for concepts offered at a conference, workshop, meeting, clinic or other training event that is intended to meet requirements for Integrated Pest Management (IPM) recertification, completed applications must be received by ACC a minimum of six (6) weeks prior to the event. The completed application will be forwarded to the Steering Committee that includes representatives from industry, Manitoba Agriculture, Manitoba Environment, Climate and Parks, for approval of CECs.

### To Complete:

1. Fill in the Event Information – this identifies who is organizing the event and their contact information.
2. Fill in the Event Session Information – this provide specific details on the each sessions. Each session must address an IPM concept. The following list identified some topic areas for each concept:
  - a. Definitions & Elements of IPM - Planning, managing, scouting, recordkeeping, evaluation
  - b. Pest Identification & Biology - Weeds, Insects, Diseases – characteristics, management
  - c. Pest Management – Cultural, mechanical/physical, chemical control, biological control
3. Submit the hours being requested. Credits are issued for one hour of session time equal to one continuing education credit. Half credits are not issued. A 1.5 hour session would be assigned 1 continuing education credit.
4. Attached the event agenda and any further information.

Failure to provide the required information using this correct application form may result in a delay in assigning credits or credits being declined.
