The MMF seeks to fill **one full-time Senior Financial Analyst** position within our **Finance Department** located at 150 Henry Ave in **Winnipeg, MB**. The Senior Financial Analyst is responsible for evaluating and assisting the MMF with its financial plans and economic modeling. The Senior Financial Analyst is also responsible for overseeing account reconciliation, developing financial strategies in coordination with the senior leadership team in Finance, analyzing financial data, identifying trends, and making recommendations for improvement.

Job Duties/Competencies:

- Perform financial forecasting, reporting and operational metrics tracking;
- Analyze financial data and create financial models for decision support;
- Report on financial performance and prepare for regular leadership reviews;
- Analyze past results, perform variance analysis, identify trends, and make recommendations for improvements;
- Assist in formulating the MMF's financial future direction and supporting tactical initiatives;
- Work closely with the finance team to ensure accurate and timely financial reporting;
- Coordinate with the Chief Administrative Officer and the senior finance leadership team on long-term financial planning;
- Develop performance measures that support the MMF's strategic direction.
