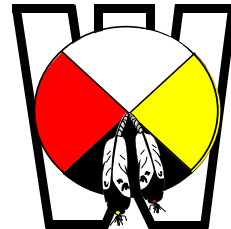

- Maintain a detailed child/special rate list using Excel for payment processing & information tracking purposes
- Processing semi-monthly foster care maintenance payments
- Verifying, coding and processing of child in care maintenance accounts payable invoices
- Maintaining and reconciling subsidiary accounts receivable ledgers and ensuring payments are collected.
- Assist in preparation of statistical and other reports, as required.
- Performing housekeeping duties in Sage 300 Accounts Payable Module
- Maintaining a filing system
- Assisting the finance department as required
