The primary responsibility of the position is to receive and process Household Hazardous Waste (HHW) materials, used oil products, containers and electronic waste (E-waste), and any other diversion materials accepted at the Eastview Landfill. To participate as part of a working team that operates a variety of equipment and machinery and performs the tasks required for the safe and efficient operations of the City's Landfill, Material Recycling Facility (MRF), Collections, and Scale Operations.

MANDATORY QUALIFICATIONS & EXPERIENCE

- Grade 12, G.E.D. , or Mature High School Diploma;
- Must possess a valid and subsisting Class 3 with Air Endorsement Province of Manitoba driver's license;
- Must hold and maintain a Transportation of Dangerous Goods Certificate or obtain within one (1) year of appointment;
- Must obtain Landfill Operating Basics (LOB) certification within one (1) year of appointment;
- Must have completed Workplace Hazardous Materials Information System (WHMIS 2015) course or obtain within 6 months of appointment;
- Must obtain a Fork Lift Operator's ticket within 90 days of appointment;
- Required to obtain and hold all certifications required by provincial regulations.

- Sufficient experience operating Equipment Operator 2 classification equipment in a safe and effective manner, such as small rubber tire front end loaders, end dump trucks, single and tandem axle trucks, refuse collection trucks.
