Manitoba and Northern Relations is seeking qualified individuals to fill Technical and Public Works Consultant positions located in Winnipeg, Dauphin, The Pas and Thompson, MB. The Manitoba government has a comprehensive benefits package which includes extended health care, health spending account, dental care, vision care, long term disability insurance, group life insurance, maternity/paternity leave, family related leave, and a defined pension plan (some pension plans allow for portability between the Civil Service Superannuation Board and employers).

Conditions of Employment:

- Must be legally entitled to work in Canada
- Candidates who possess a Diploma in Civil Engineering Technology must be willing and able to obtain their Certified Engineering Technologist (CET) designation within 12 months of the start date
- Must possess and maintain a valid full stage Manitoba Class 5 Driver's License
- Must be able and available to be on call for emergencies as required
- Must be able to travel to remote communities by vehicle, boat, small aircraft, all-terrain vehicle and/or on winter roads.
- Must be able to work overtime including evening and/or weekends if and when required.
- Within 2 years of the start date in the position, the incumbent must successfully complete the California State University Water Treatment Plant Field Study Program (Volumes I and II), and the Association of the Board of Certification's (ABC's) level II Water Treatment Exam

- Knowledge of municipal infrastructure including planning, operations and maintenance (ex: roads, public buildings, equipment)
