- Must have the ability to operate equipment that falls in the equipment operator III classification;
- Minimum of 2 years' experience in the safe operation of a motor grader for the purpose of snow clearing and removal and base/asphalt related work with finishing capabilities within City limits;
- Must obtain Transportation of Dangerous Goods Certificate within one (1) year of appointment;
- Must obtain Landfill Operating Basics (LOB) certification within one (1) year of appointment;
- Must have completed Workplace Hazardous Materials Information System (WHMIS 2015) course or obtain within 6 months of appointment;
- Required to obtain certifications required by provincial regulations.
